District and Community Profile

Located about halfway between San Francisco and San Jose, Redwood City schools are part of a vibrant, historic, culturally rich community that enjoys a charming downtown, scenic mountain vistas to the west and San Francisco Bay shoreline to the east. The district's 16 schools benefit from the involvement of active community members who donate time and resources to ensure that students receive a premier education in well-maintained, modern facilities. Redwood City schools are a vital and active participant in the community, enjoying strong partnerships with the city's Parks and Recreation Department, the Public Library and many other organizations providing services and benefits to the youth of Redwood City.

The Redwood City School District aims to be a premier California school district, and believes that children learn and succeed:

- in a safe environment with challenging and enriching instruction.
- when all students and staff are held to high expectations.
- when each of us supports their intellectual, physical, social and emotional development.
- when they have caring adults in their lives.
- in a community that respects diverse backgrounds and treats everyone equitably.
- when their ideas and involvement are encouraged and respected.
- when families actively support their learning.
- when we work in partnership with families and community.
- when all employees are highly qualified, valued and respected.
- when each of us acts on the conviction that every child can and will learn.

Test scores have been steadily rising in the Redwood City School District. We are proud of the progress we have been making, and have taken strong steps to accelerate the gains. In early 2007, the Redwood City School District put in place an Achievement Plan aimed at assuring high achievement for all students, regardless of background. Key components of the plan include:

- Teacher training.
- Use of state-adopted and research-proven curriculum and instructional strategies.
- Dedicated blocks of time for reading, writing, math, social studies and science.
- Targeted instructional groupings (TIG), where students receive differentiated instructions tailored to their specific needs (for example, English Language Development for English Learners, Reading Intervention for students reading below grade level, and Enrichment for students who are working at or above grade level.)

School Description

Orion Elementary School helps to develop educational citizens for the 21st century, which is characterized by personal habits and attitudes such as:

- Accepting responsibility for personal decisions and actions;
- Accepting responsibility for our local and global communities;
- Academic honesty and the ability to face challenges with courage and integrity;
- A healthy lifestyle;
- Empathy and courtesy for others and respect for difference among people and cultures;
- Self-confidence and a willingness to risk mistakes in order to learn;
- Sharing a fair share of the work load and managing time in a responsible manner;
- Working cooperatively with others, which includes the ability to listen, share opinions, negotiate, compromise, and help a group reach consensus.

School Profile

Orion School has provided a small, alternative choice for the Redwood City School District families since 1982. A strong parent involvement component, in the form of required parent participation, supports the program. Orion is one of three schools without neighborhood boundaries, and students come from all over the city. The student enrollment averages about 250 with nine classrooms. Orion has a small building with 5 computers in the media center and a small, but ample library. There are 32 laptops, on a portable cart, for classroom use and 45 I-Pads. The wireless internet service allows students to log on anywhere in the building. Because Orion believes in providing a well-rounded education program, it offers physical education and a variety of artistic opportunities for its students. It supports the artistic abilities of its children through chorus, art, school plays, and a variety show. The parent docent programs complement the other school programs by providing: Art in Action, Music for Minors, and gardening. Parents also help strengthen the children's bonds to school through regular classroom participation. This participation is under the teacher's direction and helps to reduce the adult-to-child ratio. Orion has a Starship Board, comprised of the chair of each parent committee, designed to promote the representation and voice of all within the school, as well as to improve the coordination of the calendar, activities, and resources. The school has four parent representatives on the School Site Council. Everyone at the school, the custodians, aides, office manager, special education support personnel, teachers, administrator, and parents, put their hearts into making Orion a special place. It is their family. They assiduously work together to create an environment that feeds the mind and souls of its children.

California Distinguished School

In May of 2008 Orion was awarded the California Distinguished Schools Award.

Opportunities for Parental Involvement

Orion School understands how important parent involvement and support is in the success of students. For this reason, Orion School has a parent participation requirement. Parents make a commitment to participate in school activities, school committees, and volunteer in the classrooms. School committees include: Starship Board, School Site Council, Starship Fundraising, English Learners Advisory Council (ELAC), Green Club, Art-in Action, Health and Nutrition, Library, Author and Illustrator and many more. School Safety Plan

The School Site Safety Plan is evaluated and revised annually by members of the School Site Council and the Safety Committee. Revisions to the Safety Plan are communicated to staff members annually. Key elements of the Safety Plan include: Emergency and Disaster Planning, Child Abuse Reporting and School Discipline.

The school is in compliance with the laws, rules, and regulations pertaining to hazardous materials and state earthquake standards.

The school's disaster preparedness plan includes steps for ensuring student and staff safety during an emergency. Fire drills are conducted monthly, earthquake drills occur once a year and lockdown drills are practiced twice a year.

The safety of students and staff is a primary concern of Orion School. To ensure student safety, supervision is provided on campus at all times. Teachers and the administrator supervise students before and after school, as well as during breaks. All visitors to the school must sign in and out at the office and have prior authorization for classroom visits.

Orion School was originally constructed in the 1950s and remodeled in the 1990s. It is currently comprised of nine classrooms, one computer area, one library, one multi-purpose room, one staff lounge, an administrative support center, and two playgrounds.

The school was completely modernized in 1997 as the result of two separate bond projects (Measures A & B). Measure A renovations were completed on all classrooms by October 1997. At that time, Orion School received a new library/ media center, and a reclaimed cafeteria/multi-purpose room and administrative support center.

Measure B projects have been completed at variable times over the past three years and have included/will include: installation of energy-efficient lighting; replacement of damaged fencing; repairs to landscape; fresh painting; and campus-wide American Disabilities Act (ADA) improvements. Professional Development

Staff members build teaching skills and concepts through participation in conferences and workshops throughout the year. For the past three years, the District has sponsored three staff development days, where teachers are offered a variety of growth opportunities. Topics for staff development during the 2012-13 school year included: Instructional Strategies for the Common Core Standards, Technology Integration in the classroom, Explicit Direct Instruction, FOSS science kit training, Training, Reading Assessment Training for K-2 Teachers and English Language Development strategies. The District also created an optional training program for teachers called RCSD University. This differentiated program allows teachers to choose workshops based on topics they are interested in pursuing.

For additional support in their profession, teachers may enlist the services of the district's Beginning Teacher Support and Assessment (BTSA) facilitator and/or the Peer Assistance and Review (PAR) program.

Year and month in which data were collected: September 2013

All Redwood City School District students have equal access to state adopted, standards aligned textbooks and instructional materials. Funds are appropriated according to the textbook adoption cycle. Additional supplemental materials are purchased and made available to students. All instructional materials are aligned to the standards and available for each student.

Pursuant to the settlement of Williams vs. the State of California, Redwood City School District thoroughly inspected each of its school sites at the start of the 2013-2014 school year to determine whether or not each school had sufficient and good quality textbooks, instructional materials, and/or science laboratory equipment. All students, including English Learners, are required to be given their own individual textbooks and/or instructional materials (in the four core subject areas: English language arts, mathematics, history/social studies and science), for use in the classroom and to take home if necessary. Additionally, all textbooks and instructional materials used within the District must be aligned with the California State Content Standards and Frameworks, with final approval by the State Board of Education.

The Redwood City School District Textbook selection is done by a District, grade level and subject area committees coordinated by the Deputy Assistant Superintendent of Curriculum and Instruction. The final textbook selections for grades K-8 from the current approved State lists are then selected and the recommendation goes before the School Board for final approval.

The Standardized Testing and Reporting (STAR) Program consists of several key components, including:

- **California Standards Tests (CSTs)**, which include English-language arts (ELA) and mathematics (Math) in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science (H-SS) in grades eight, and nine through eleven.
- **California Modified Assessment (CMA)**, an alternate assessment that is based on modified achievement standards in ELA for grades three through eleven; mathematics for grades three through seven, Algebra I, and Geometry; and science in grades five and eight, and Life Science in grade ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations.
- **California Alternate Performance Assessment (CAPA)**, includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations.

The assessments under the STAR Program show how well students are doing in relation to the state content standards. On each of these assessments, student scores are reported as performance levels.

Academic Performance Index Ranks - Three-Year Comparison

This table displays the school's statewide and similar schools' API ranks. The **statewide API rank** ranges from 1 to 10. A statewide rank of 1 means that the school has an API score in the lowest ten percent of all schools in the state, while a statewide rank of 10 means that the school has an API score in the highest ten percent of all schools in the state. The **similar schools API rank** reflects how a school compares to 100 statistically matched "similar schools."
