  - 6.1 Recognition of Hoover Community School

In December, Hoover experienced several cases of Norovirus, a highly contagious stomach virus. Every weekend in December, including all of winter break, custodians, bus drivers, instructional assistants yard duty and food service staff came to the Hoover campus to disinfect every surface on campus.

The Boys and Girls' Club has provided Hoover Community School with an extended day learning program, which has extended from serving 100 middle school students to

320 students ranging from kindergarten to eighth grade. The Boys and Girls' Club has provided additional support for students by providing blended support learning, time for reading, homework support and enrichment.

School Board Trustees and Superintendent Baker expressed their utmost thanks to RCSD's Facilities' Department and the Boys and Girls' Club for their service to Hoover Community School students and the Redwood City School District.

At the February 15th board meeting, Chief Business Official Saleh, Superintendent Baker and the School Board began a discussion on possible budget reductions for the 2017-18 and 2018-19 to balance the budget. At this board meeting, the School Board continued the discussion on the recommended budget reductions and the RCSD administration made a recommendation to the School Board.

Angela Gervacio Sosa, lead custodian at John Gill School, thanked the School Board for their endless support of custodians and the Facilities' Department. Ms. Sosa expressed that cutting custodian positions district-wide would affect staff, teachers, and students. Ms. Sosa reiterated her acknowledgement of the dire need of budget cuts, but urged the School Board to consider keeping custodians, as lack of custodians mean that classrooms would be cleaned fewer times during the week, which could increase sickness amongst teachers, students and staff.

Maria Stockton, Clifford School staff, urged the School Board to consider keeping all custodial positions.

The Board approved the budget reductions for the 2017-18 and 2018-19 school years (Lawson, MacAvoy; 5-0).
