7. School/Community Reports

7.1 Bond Program Update

Don Dias, Director of Bond Construction provided the School Board with a presentation and information about the timeline of projects for Measure T.

Superintendent Baker commented that the Educator Effectiveness funds are intended to provide funding to county offices of education, school districts and charter schools to provide beginning teacher and administrator support and mentoring, professional development, coaching and support services for teachers identified as needing improvement or additional support, professional development for teachers and

administrators aligned to the state standards, and to promote educator quality and effectiveness.

Superintendent Baker added that the Redwood City School District plans for the Educator Effectiveness funds to be used for the following purposes: 2 full time technology coaches, stipends for professional development, conferences, and substitute release days.

Chief Business Official Saleh further added that the funds may be expended anytime during the 2015/16, 2016/17, and 2017/18 fiscal years. A final expenditure report will be due at the end of the 2017/18 fiscal year. Any funds not expended by June 30, 2018 must be returned to the CDE.
