## 1. Call to Order

  - 6.1 Public Hearing: Input on Draft Trustee Area Boundary Maps

At its November 15, 2017 board meeting, the School Board received information about the process for drawing the trustee area boundary map from National Demographics Corporation. Following the presentation, the School Board has a discussion regarding the criteria to be used drafting the boundary maps.

On November 29, 2017, the first draft of the trustee area boundary maps ("Green," "Orange," and "Purple") were posted on the District's website and the School Board

held a public hearing and provided input on the maps at its meeting on December 6, 2017.

Revised maps were subsequently posted on the District's website, adding maps, "Purple 2A" and "Purple 2B" and the School Board held a second public hearing on those revised maps during its meeting on December 12, 2017. At that time, due to legal concerns with the "Purple 2B" map and other concerns with the "Orange" map, the School Board decided to focus its future discussions on maps, "Green," "Purple," and "Purple 2A."

Superintendent Baker stated that the primary purpose of the Public Hearing was for the School Board to discuss and decide on a final map to bring forward to the January 10<sup>th</sup> board meeting for a final approval.

Demographer Shalice Tilton reiterated that the "Green," "Purple" and "Purple 2A" maps met the California Voting Rights Act requirements.

After an extensive discussion, each School Board member expressed their preference as follows:

President Díaz-Slocum – Purple Map Vice-President McBride: Purple Map Trustee Lawson – Green Map Trustee MacAvoy – Purple Map Trustee Paulson – Purple Map

Attorney William Tunick and Superintendent Baker commented that a Resolution to approve the Purple Map would be placed on the January 10<sup>th</sup> agenda.
