The Redwood City School District (RCSD) has provided on-going opportunities for stakeholders to provide input into the priorities for expenditures for both state and federal funding. In addition to the monthly meetings that were held in the spring and summer to develop and prioritize goals and aligned expenditures in the 2021-22 LCAP, an additional meeting was held on September 28 to for stakeholders to provide feedback on, suggest and finalize ESSER expenditures. Members of the standing LCAP committee, along with additional advocacy group members, district staff and community members attended the September 28 meeting, which was held in English, with simultaneous Spanish translation. Breakout discussion groups were provided in both English and Spanish only, in order to provide opportunities for equity of voice and highlighting specific questions and ideas pertaining to the variety of communities represented in the RCSD district. County Office SELPA representatives were also present in the September 28 meeting, along with district Board members, cabinet members, site administrators, certificated and classified bargaining members and the Superintendent of RCSD.

The RCSD engaged in meaningful conversation with Innovate Public Schools, an advocacy group, and several of their members were in attendance at the September 28 meeting. The RCSD evaluated its stakeholder opportunities and determined that additional Civil Rights Groups/Tribes are neither present nor served by the LEA.

Feedback from this and the prior LCAP meetings show that our community is concerned about the impact of prior at-home learning experiences on student learning and mental health. One-one tutoring was emphasized, reaching out to community partners to support both tutoring and mental health needs, outreach and training for families and training for teachers in inclusive practices were priorities established by the ESSER committee. These priorities, while addressed in the 2021-22 LCAP, are also re-emphasized in the ESSER III plan.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.
