Each school site will also need to complete a board-approved Site Plan for Student Achievement tat reflects the allocated funds from Title I and details of how the school site plans to expend the funds following the legal requirements of the programs.

The Consolidated Application for Federal Funding Programs will be presented to the School Board for approval in early September 2017.
